1:00 p.m. – Intramural fields will be open for batting practice for Home Run Derby contestants. Contestants are responsible for their own bats, balls, and pitchers for practice.

1:45 p.m. – Contestants report to Jane B. Moore Field.

2:00 p.m. – Contestants will be announced and contest begins.

WHERE: Jane B. Moore Field, Auburn University Softball Complex, Auburn, AL

TICKETS: The event is open to the public. Tickets are \$3 per person, available at the door. Children 6 and under are free.

HOW TO ENTER: Each of the 24 teams participating in the Dixie Youth World Series will nominate one player to be their representative in the Century 21 Paramount Home Run Derby. Contestants will be broken down into 2 divisions- nine/ten year-olds and eleven/twelve year-olds. Coaches need to fax or mail in the Nomination and Permission Form to Century 21 Paramount Real Estate, Inc. as soon as possible.

Competition Rules:

First Round

- Field consists of 12 hitters
- Each hitter will receive 10 pitches or 8 swings
- The 4 hitters with the most home runs in this round move on to the Semi-Final Round

In Case of a Tie: All players that tie will advance to the next round.

Semi-Final Round

- Field is narrowed down to top 4 hitters from First Round
- Each hitter will receive 8 pitches or 6 swings
- The 2 hitters with the most home runs in this round move on to the Final Round

In Case of a Tie: The player's scores from both rounds will be added together.

Final Round

- Field is narrowed down to top 2 hitters from Semi-Final Round
- Each hitter will receive 8 pitches or 6 swings
- Hitter with the most home runs in this round will be declared the Century 21 Paramount Home Run Derby Winner

In Case of a Tie: The player's scores from all rounds will be added together.

A pitching machine will be used to pitch to the hitters. Scoring is not cumulative, but will be reset each round. A Home Run is when a player hits the ball over the wall (or designated marker). Two umpires will be available as needed. All judgements of the umpires will be final.

In Case of Rain, contest will not be held.

Each Home Run Derby contestant will receive a T-shirt, baseball and certificate for participating. The Home Run Derby Winner and Runner-up in both divisions will be awarded a Home Run Derby trophy in addition to his t-shirt, baseball, and certificate.

All contestants will be recognized at the Dixie Youth World Series Opening Ceremonies. Century 21 Paramount will present the trophies and a check for the scholarship fund at the ceremony as well.

Jane B. Moore Field at the Auburn Softball Complex was named in honor of Moore for her long-time service to Auburn University athletics. Moore, a retired professor and director of graduate studies in the Health and Human Performance department, was the first woman to serve on the Auburn University Committee on Intercollegiate Athletics. The facility seats 1,500 and includes a concession area, a press box, two luxury boxes and an indoor batting cage with three hitting tunnels.
